Report County Commissioner reported Region 2 Agency on Aging changing its name to Well Wise. End of public health emergency is now in place. Equalization Report is now available. Jackson County Department of Transportation working on roads not many in Spring Arbor. General Government Committee with the County contracted an energy management company using ARPA funds and a Federal grant.

<u>Police</u> County Sheriff reported radio service added within the jail. Temporary roof repair successful. Commented regarding employee retention issues. Attended Drug Summit. NARCAN machine added to jail. Attending Violence Summit at Jackson College next week. Fundraising run raised funds for providing car seats and installation instruction. Open house in June for police department tour to raise money.

Police Chief reported all officers attended and passed Drug Summit training. NARCAN now in all patrol cars. He attended Dispatch Policy Meeting, not many changes necessary. Received two raid helmets from FEMA.

<u>Fire</u> Fire Chief reported various trainings attended. Fire now carrying NARCAN. Fire class finishing May 13th. Pancake Day, May 6th and May 20th, Clean-up Day. Reported possible change of method for administering meds following training.
